

**Ashippun Town Board Meeting**  
**October 9, 2008**

Chairman James Schoenike called the monthly Town of Ashippun board meeting to order on Thursday, October 9, 2008 at 7:00 p.m. at the Ashippun Town Hall. Pledge to the flag was given.

The clerk verified that meeting notices were properly given. Roll call was taken with Chairman James Schoenike, Supervisor David Wendorf, Supervisor Roger Kopfer and Clerk/Treasurer Vickie Schlieve as all being present.

Approval of minutes from September 11, 2008 Town Board meeting – Supervisor Kopfer moved to accept the minutes as printed. Seconded by Supervisor Wendorf. All in favor. Motion carried.

Public Input – none at this time.

Police Report – Officer Vossekul presented the monthly report for September.

Clerk Schlieve read the Treasurer's report for September. Motion by Supervisor Wendorf to accept the Treasurer's report as read. Seconded by Supervisor Kopfer. All in favor. Motion carried. Clerk Schlieve read the list of bills presented for payment. Motion by Supervisor Kopfer to pay the bills. Seconded by Supervisor Wendorf. All in favor. Motion carried.

Don Christopherson, Building Inspector – The report for September was given. It was noted that Judy Sebastian is intending to secure a building permit for a duplex at W2423 & W2425 Julianne St. Established town ordinances need to be enforced.

Larry Krier, Highway Department – Larry questioned the speed limit on Erin Road and if it could be reduced. All of the roadsides are cut.

The October 2, 2008 Planning Commission meeting minutes were read by Clerk Schlieve and accepted as printed.

Unfinished Business: Discussion and updates on Roosevelt Road project – Asphaltting will begin next week. Curbing will be done on Monday.

Discussion and updates on Davy Creek – A group from Ashippun met with Jim Condon at the DNR office in Horicon and were informed that a cleanup could occur from Lincoln Road past the firemen's park and that an engineered plan would be necessary to proceed. This topic could be brought up at the upcoming special elector's meeting.

New Business: Discussion and possible approval of new Operator's License through June 30, 2009 for Diane Bouzide, working at Ashippun Bp. The background check came back clear and she was not able to attend this meeting due to work. Supervisor Kopfer moved to approve the operator's license for Diane Bouzide and seconded by Supervisor Wendorf. All in favor. Motion carried.

Discussion and possible approval for the chairman and the clerk to sign the certified survey map for Randy Rolefson, N2080 Resthaven Road for a 1.2 acre split from existing parcel to separate buildings from acreage. Supervisor Kopfer moved to approve the chairman and clerk to sign the certified survey map, seconded by Supervisor Wendorf. All in favor. Motion carried.

Discussion and possible approval of how to handle fall yard debris. The discussion opened up to the public. Dennis Gimmel spoke on a monitored place for debris. Ray Zuercher explained Pewaukee's debris disposal system. The Town of Oconomowoc is looking for a new area to handle this. The Town of Ixonia has a dumpster. Jim Schlieve suggested having a dumpster available for Saturday and then moved into the garage to avoid abuse of privileges. Chairman Schoenike proposed that a cement "bunker" be set up for leaves and brush at the Recycling Center. The expense would be about \$20 per block and we require 12 of them. Don Kehl suggested installing a camera security system. There would be no charge to users at this time.

Discussion on Dodge County Planning hearing on the petition to amend the text of the Land Use Code to clarify certain definitions used within the code to be held on October 20, 2008 at 7:45 p.m. There was no discussion or questions.

Set date for budget workshop. The budget workshop will be Thursday, October 16, 2008 at 7:00 p.m. The time was moved to 6:30 p.m.

Correspondence: Clerk Schlieve reported that there would be a special voter registration drive on Saturday, October 18<sup>th</sup> from 9:00 am to 11:00 am at the town hall.

Public Input: Dave Guckenberger expressed his frustration with the Highway O construction project. The brochure from the town board regarding the November referendum was well presented. Don Kehl asked if the dredging of Davy Creek needed to be 27 feet wide.

Supervisor Kopfer moved to adjourn the meeting at 7:55 p.m. Supervisor Wendorf seconded the motion. All in favor. Meeting adjourned.
